> 2.1The candidates provisionally allotted seats shall perform the below mentioned activities by 14.06.2025.

> > 2.1.1 Submit copy of sanction order of <u>leave for</u> <u>purpose</u>'f r o m their Appropriate study Authorities to ESIC Hgrs. Office (via email; mecell.hq@esic.nic.in)

Note: All candidates are requested to complete the process for sanction of leave for study from their Appropriate Authorities in a timely manner. Candidate of ESIC Institution may initiate the process through proper channel and also make a copy of the communication med4-hg@esic.nic.in

> 2.1.2 Submit proof of deposit of one - year nonrefundable Course F e e of ₹1.25.000/-(excluding payment gateway charges) in ESI-Fund A/c No. 2, details for which may be obtained from the concerned institutions (ESIC candidate may deposit the fess at the institute where he/she is posted).

> 2.1.3 Submit Acceptance for the seat along with request for Retention of seat via email at mecell.hg@esic.nic.in).

2.2 Failure to submit timely information as per Para(2.1.1). Para (2.1.2) and (2.1.3) in r/o the seat shall lead to;

2.2.1 Loss of the said seat;

2.2.2 The said candidate shall stand exited

from the process of further counseling altogether.

2.3 Candidates will be allowed to report to the allotted institute only after allotments pursuant to the Second Round of Counseling, if any. The original documents are to be verified by the allotted institute.

2.4 After second round, all the candidates provisionally allotted DNB seats shall carry originals with attested copies of documents for verification as under;

2.4.8 Copy of sanction order of 'leave for study purpose' from their Appropriate Authorities, to ESIC HQ office.

2.4.9 Proof of deposit of one-year non-refundable Course Fee of ₹1,25,000/- (excluding payment gateway charges) in ESI-Fund A/c No.2.
